NOTICE OF INTERIM SCHOOL GOVERNING BODY ELECTION

Please take note that an interim School Governing Body election must take place, before the end of March 2026.

The composition of the School Governing Body of Vaalpark Primary School must be as follows:

3. One (1) non-educator staff member attached to the school, nominated and elected by them.
4. The school principal in an official capacity.
5. Learners of Vaalpark Primary School are not represented.

Therefore there are three (3) vacant positions in the parent component of the School Governing Body.

Nominations may be submitted by completing a nomination form and submitting it to the school's electoral officer. Nomination forms will be available from the school, from 9 February 2026 and must be submitted to the school. The form must be completed by the candidate, the proposer, and the seconder. Both the proposer and seconder must be parents/guardians of learners, at the school.

Completed nomination forms must be submitted to the school office, between 10 February and 23 February 2026. Valid nominations will also be accepted during the nomination/election meeting. Proxy votes will not be accepted.

NB: A nomination meeting will be held in the school hall, on 5 March 2026, from 18:00 to 18:30. If more than three (3) candidates are nominated at this meeting, an election will be held on 9 March 2026, from 12:30 to 14:30.
